Amount of CSR contribution:

The support committed by the Company for the Financial Year 2025-26 Rs. 26,77,758 (Rupees Twenty - Six Lakhs Seventy-Seven Thousand Seven Hundred and Fifty-Eight).

Mode of implementation of CSR activity:

The CSR activity shall be implemented through below mentioned NGOs:

1. Parivaar Education Society

We partnered with Parivaar Education Society, a non-profit organization that is a pioneer in providing quality education and holistic care to vulnerable children. The organization focuses on the development of orphans, abandoned, and underprivileged children from tribal communities by offering free residential education, healthcare, and life support in a nurturing environment. Parivaar operates residential institutions in West Bengal and has expanded its presence to Madhya Pradesh and other regions through its network of Seva Kutirs, which provide supplementary education, nutrition, and community support. It also undertakes various humanitarian initiatives, including healthcare services and broader social welfare programs.

Activities to be undertaken:

- Provide financial aid for operational expenditure of 126 resident children at a residential institution in Village Sandalpur, District Dewas, Madhya Pradesh.

2. Parmarth Seva Samiti

Parmarth Seva Samiti is a Mumbai-based non-governmental public charitable Trust dedicated to the welfare and empowerment of underprivileged communities. PSS focuses on key areas such as health, education, women's empowerment, and community welfare. Mode of implementation of CSR activity:

1. Ashoka University (International foundation for Research and Foundation)

3. P M Cares Fund

Keeping in mind the need for having a dedicated fund with the primary objective of dealing with any kind of emergency or distress situation, like posed by the COVID-19 pandemic, and to provide relief to the affected, a public charitable trust under the name of 'Prime Minister's Citizen Assistance and Relief in Emergency Situations Fund (PM CARES Fund)' has been set up. PM CARES Fund has been registered as a Public Charitable Trust. The fund consists entirely of voluntary contributions from individuals/organizations and does not get any budgetary support. The fund will be utilised in meeting the objectives as stated above. Donations to PM CARES Fund would qualify for 80G benefits for 100% exemption under the Income Tax Act, 1961. Donations to PM CARES Fund will also qualify to be counted as Corporate Social Responsibility (CSR) expenditure under the Companies Act, 2013.
